## Filtration System GXRTLL

- This system has been tested and certified by IAPMO R&T against NSF/ANSI Standards 42 for the reduction of the substances listed below. The concentration of the indicated substances in water entering the system was reduced to a concentration less than or equal to the permissible limit for water leaving the system, as specified in NSF/ANSI 42.
- Actual performance may vary with local water conditions.


To reduce the risk associated with ingestion of contaminants: do not use with water that is microbiologically unsafe or with water of unknown quality without adequate disinfection before or after the system.

Limited 30 Day Warranty.

If your GE Appliances filter fails because of a manufacturing defect within 30 days from the date of original purchase, GE Appliances will exchange the defective filter for a new GE Appliances filter without charge. Return the defective filter to the retailer where it was purchased with a copy of the "proof of purchase".

If the filter is defective, it will be replaced.

This warranty does not cover filters that are improperly installed, damaged, abused or used for other than the intended purpose.

It does not include the cost of returning the filter to the retailer where it was purchased, the labor to remove, install or diagnose the failure, parts used in commercial applications and incidental or consequential damage caused by possible defects with the unit.
