

# **ENGLISH**

# Connecting and Using the Speaker

- Charge the speaker before using it by opening the rear cover and connecting the speaker to the charging adapter.
- 2 Charging a smartphone
- 1 Press the **Power** button on the speaker to turn it on.
- (!) You can only charge your smartphone in **Bluetooth** mode
- ② Open the back cover of the speaker and connect the smartphone to the DC OUT (5 V == 2 A) terminal via the USB cable. The smartphone starts to be charged.

# 3 Connecting to an External Device

- 1 Press the **Power** (b) button on the speaker to turn it on.
- ② Open the back cover of the speaker and connect the external device to the AUX terminal via a 3.5 mm stereo cable.
- 3 Turn the external device on and start playing.

- 4 Connect the speaker to a smartphone via Bluetooth
  - 1 Press the Power button on the speaker to turn it on. Bluetooth LED blinks.
- (2) Press the Settings button on the smartphone and select Bluetooth Turn on the Bluetooth function.
- (3) Find "LG-XG9Q (XX)" on the device list on the smartphone and connect to it. Once the smartphone is connected via Bluetooth, the Bluetooth LED will turn on.
- On the smartphone, play a music of your choice.

- **5** Connecting the LG XBOOM App
- (1) Find LG XBOOM app on the Google Play or App Store and install it on your smartphone.
- (2) Run the LG XBOOM app and use more features. (EQ, Wireless Party Link, Lighting, Sleep Timer, Setting etc.)

If you and LG are unable to resolve the dispute within 30 days, either party may proceed to file a claim for arbitration.

Agreement to Binding Arbitration and Class Action Waiver. Upon failure to resolve the dispute during the 30-day period after sending written notice to LG, you and LG agree to resolve any claims between us only by binding arbitration on an individual basis, unless you opt out as provided below.
