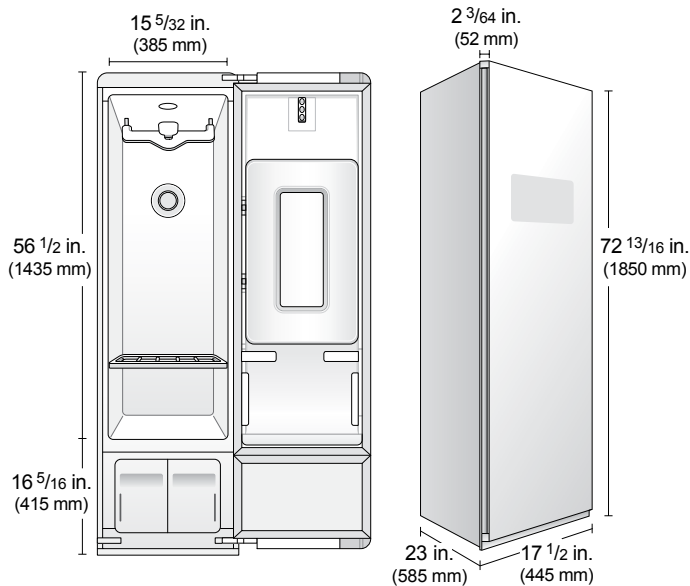

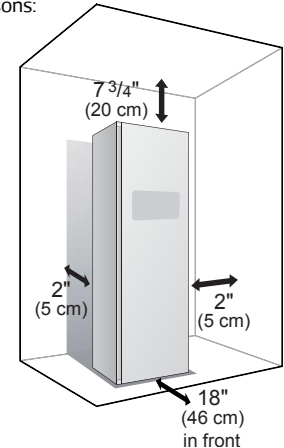

**PRODUCT DIMENSIONS****CLEARANCES****Recommended Installation Spacing**

The following clearances are recommended for the Styler. Although the Styler has been tested for clearances of 1 3/16 inch (3 cm) on the sides and rear, recommended clearances should be considered for the following reasons:

- Additional space should be considered for ease of installation and servicing.
- Additional space might be required for wall, door and floor moldings.
- Additional space should be considered on all sides of the Styler to reduce noise transfer.
- Additional laundry appliance spacing should also be considered.

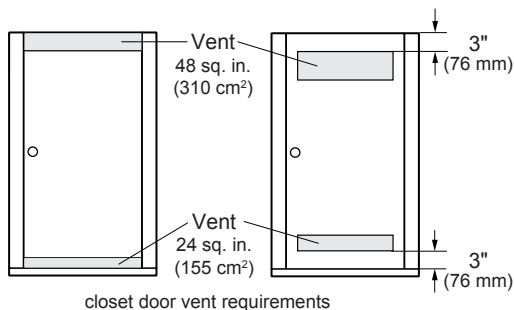
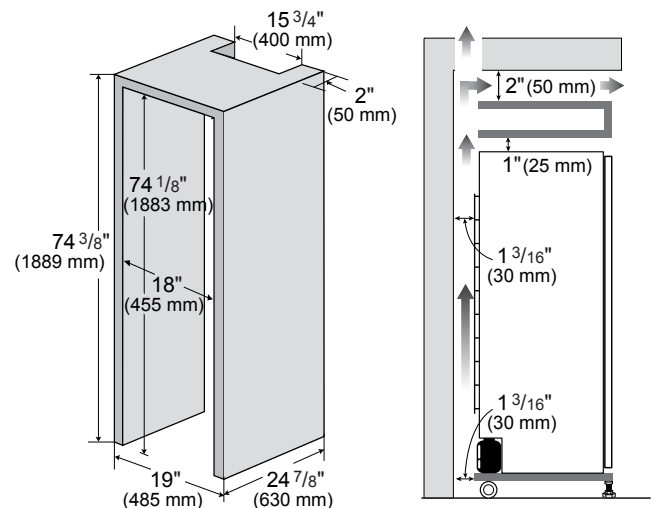
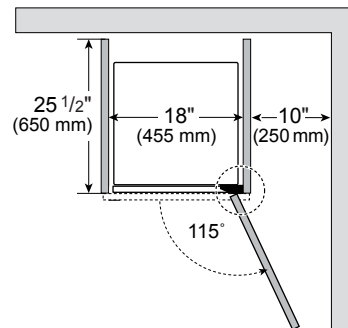
**CLEARANCES****Installation Spacing for Recessed Area or Closet Installation**

There should be at least a little space around the Styler (or any other appliance) to avoid contact with walls, furniture, or other appliances during operation. Allow a minimum of 1 3/16 inch (3 cm) on all sides of the Styler to avoid increased noise or damage.

- For closet installation, with a door, minimum ventilation openings in the top and bottom of the door are required. Louvered doors with equivalent ventilation openings are acceptable.
- Minimum vent opening for built-in installation is 31 1/2 sq. in. (200 cm<sup>2</sup>).

**Closet Ventilation Requirements**

Closets with doors must have both an upper and lower vent to prevent heat and moisture buildup in the closet. One upper vent opening with a minimum opening of 48 sq. in. (310 cm<sup>2</sup>) must be installed no lower than 6 feet (185 cm) above the floor. One lower vent opening with a minimum opening of 24 sq. in. (155 cm<sup>2</sup>) must be installed no more than one foot above the floor. One example shown uses vent grilles in the door.

**Built-In Installation**
