

Care Instructions

Your Clare Bedding sleep set has been constructed with the finest resilient upholstery materials and designed to conform to your individual contour.

To prolong the life of your Clare Bedding sleep set and be more satisfied with its overall performance, please remember the following points:

1. Your new sleep set may reveal body signatures. This is normal and not a structural defect. The upholstery materials are conforming to the weight and shape of your body, thus reducing pressure points.
2. Do not bend the mattress. This could damage the innerspring unit. It should only be carried flat or on its side.
3. Use a mattress pad. This will protect your new set and help keep it clean.
4. Handles (when provided) are designed to aid in sliding or shifting the mattress on the foundation, not to carry it.
5. Rotate your mattress "foot end" to "head end" every few weeks to add to it's durability and uniform comfort.
6. If you have a 2-sided mattress, flip over every few weeks. This will allow the upholstery layers to refresh and recover.

Clare Bedding Limited Warranty

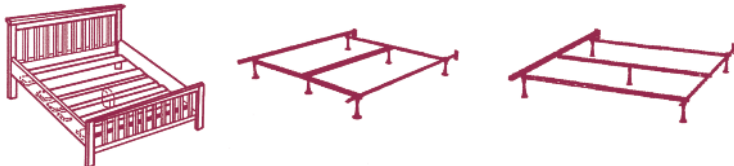
Congratulations on the purchase of your new **Clare Bedding** sleep set! Your mattress and foundation have been manufactured by **Clare Bedding** to exacting specifications. The finest quality, care and craftsmanship goes into every sleep set, thus providing you with years of comfort and support.

Clare Bedding warrants against defects in workmanship and material (excluding the cover and handles) of the sleep set. In the unlikely event that service is required because of such defects, your mattress and/or foundation will be repaired or replaced (at **Clare Bedding's** option) without charge, except for transportation costs. If you observe a defect, contact the dealer from whom you purchased the set. If the dealer cannot be reached, you should write directly to **Clare Bedding's** manufacturing plant. To redeem your warranty, a legible proof of purchase must be provided (including date of purchase).

Additional Limitations:

1. **Clare Bedding** reserves the right to refuse service when the product is found to be in an unsanitary condition, soiled, stained or when failure is due to causes other than defective materials or workmanship.
2. The terms of this **Clare Bedding** limited warranty are negated if the product is used for (but not limited to) commercial purposes such as in a hotel, motel or nursing home.
3. If identical materials are not available at the time of repair, **Clare Bedding** reserves the right to substitute materials of equal or better quality.
4. Your new **Clare Bedding** sleep set is engineered as a system so that it is more resistant to open flames. **Clare Bedding WILL NOT** warrant your bed set, and your bed set's open flame resistance may be seriously impaired, if a non-matching mattress and foundation are used together, using a non-matching foundation and mattress together voids all terms of this warranty. (Exceptions for mattresses used with bunkbeds or platform beds.)
5. **Queen and king sizes require a center support leg that extends to the floor. Headboards/footboard/side rail beds require a minimum of (5) 1" x 3" cross slats with at least one center leg that extends to the floor.**

On queen and king-size models, center support that extends to the floor is required.

Any and all implied warranties on this product shall not exceed in duration the term of this limited warranty. Incidental or consequential damages are excluded. Some states do not allow the exclusion or limitation of incidental or consequential damages or limitations on how long an implied warranty lasts, so the above limitation or exclusion may not apply.

This warranty gives you specific legal rights. You may also have other rights which vary from state to state. This warranty is given by the manufacturer whose name and address appear on the law label attached to your **Clare Bedding** product. This warranty is given only to the initial purchaser and is effective from the date of purchase.

Attached to every **Clare Bedding** sleep set is a law label which includes a warranty code. To determine the terms or your warranty, match the warranty code with the appropriate line in the warranty schedule.
